- 2.1 Payment: 50% at the time of signing the Term of Agreement and the remaining 50% when the arbitration judgement is rendered.
- 2.2. The Administration Fee shall be divided equally between Petitioner and Defendant.
- 2.3. If there is more than one Petitioner or Defendant, the share of half of the costs attributed to the plaintiff's or defendant's side will be divided, internally, in equal amounts between the members of each joinder.
- 2.4. Without the payment of the first installment of the administration fee, the arbitration proceeding will not be initiated by the arbitrators and without the payment of the last installment, the arbitration judgement will not be disclosed by ABDM.
- 2.5 A party may pay the share of the Administration Fee under the responsibility of the other party that is in default, in order to avoid the interruption of the arbitration procedure, except for its right to any reimbursement, under the terms of what the arbitration judgement decides.
